AARP Fights Cuts to Medicaid, Food Assistance

Proposed cuts to <u>Medicaid</u>, food assistance and long-term care that could impact millions of low-income older adults are heading for a final vote in the House as AARP urged lawmakers to protect those programs.

Senate Republicans narrowly passed their version of President Trump's domestic spending and tax bill on Tuesday and House lawmakers will now consider the legislation.

The bill slashes the Supplemental Nutrition Assistance Program and health care for low-income people and people with disabilities and aims to dramatically reduce federal spending to deliver on the Trump administration's priorities, including an extension of the President's tax cuts.

"This is a moment to strengthen — not weaken — the supports that help people stay in their homes, access needed health care and live with dignity and independence," wrote Nancy LeaMond, AARP's chief advocacy and engagement officer, in the June 29 letter to Sens. John Thune (R-S.D.) and Chuck Schumer (D-N.Y.). Read more.

AARP Supports Tax Provisions For Older Americans

Tax provisions that could decrease taxes paid by older adults, allow for more caregiving leave and increase access to affordable housing are included in a budget bill heading for a final vote in the House.

The latest version of the spending bill narrowly passed the Senate on Tuesday after several hours of voting overnight on amendments, in time to meet President Trump's July

breaks.

Some of the proposals passed by the Senate could help older adults who often grapple with increasing costs on everything from housing to prescription drugs. An increase in the additional senior standard deduction for those 65 and older, from \$1950 to \$6000, would help offset taxes that many older Americans pay on Social Security benefits. This senior bonus deduction would be in addition to the standard deduction available to all taxpayers.

"This increase delivers tax relief at a time when many older Americans are living on fixed incomes while facing rising costs," wrote Nancy LeaMond, AARP's executive vice president and chief advocacy and engagement officer in a June 29 <u>letter</u> to Senate leaders. <u>Read more</u>.

NEW Public Pension Research

A new report from the National Institute on Retirement Security (NIRS) and Aon, Evolution and Growth: How Public Pension Plans Have Diversified Their Investments Amid Changing Markets, examines the changes public pension plan investing has undergone throughout the twenty-first century.

After decades of investing primarily in bonds and other fixed income assets, public pension plans have shifted to more diverse investment portfolios, which enabled these funds to grow, deliver reliable benefits, and withstand market turmoil during and after the 2008 Global Financial Crisis. The report finds:

- Public pensions have significantly diversified their portfolios.
- Plans have adopted the prudent investor rule throughout the twentieth century.
- Pension funds responded to significant changes in financial market conditions.
- The decade of ultra-low interest rates was a notable period of transition and change for public plan investments.
- More diverse pension plan portfolios have performed strongly in recent years.

This report can serve as a tool to educate retired educators about their retirement plans, as well as a resource for educating state and local policymakers about your pension plan.
