# Local Associations Awarded for Service

Between 2020 and 2022, the MRSPA Community Service Committee suspended awarding local associations for outstanding community service projects because many activities moved to virtual or drive-through events because of the pandemic. 2023 saw the return of local association awards for community service projects.

During the May 2023 Annual Business Meeting, Community Service Committee Chair Kathy Campagnoli, Frederick County, presented the following local associations with \$100 checks to support their outstanding community service projects.

#### Small Local Association (1-199 mem-



bers): Caring is Sharing - Garrett County Retired School Personnel Association provides and replenishes little laundromat libraries in laundry bas-

kets at 5 community laundromats throughout the county.

Medium Local Association (200 - 899 members): Crocheting for Comfort – Washington County Retired Educational Personnel Association members learned how to crochet. They created large, crocheted mats from



plastic bags and donated 16 mats. The mats function as a moisture barrier for unhoused people through the REACH shelter for use when sleeping outdoors. Between 500

and 700 plastic bags were recycled in each mat. Eighteen tote bags were also crocheted and filled with toiletry items for women at CASA.

#### Large Local Association (900+ members): Interfaith Works – Montgomery County Public



Schools Retirees Association donates gently worn clothing, gently used household items, and cash to Interfaith Works for families in need. MCPSRA members also volunteer to sort and package the items for

shoppers.

Other project nominees were: Medium local – Cecil County – Teacher Mini-Grants and Harford County – Boys and Girls Clubs.

The MRSPA Community Service Committee is so proud of all the work our members do in the community! Nomination forms for the 2024 awards will be available in January.

Weird emails, text messages, phone calls from numbers you think you know; criminals are very good at trying to steal your personal or your bank account information or your entire identity.

Because the MRSPA Consumer Education Committee is well aware of these scam attempts, they have scheduled a new Fraud and Scams webinar for Tuesday, November 21, 2023, from 10:00 to 11:00 a.m. This webinar will be presented by FBI agent, SSA Keith Custer. His specialty area is cybercrime. There will be time to ask questions after the presentation.

You likely know someone who has been impacted by a scam or fraud if you haven't been a victim yourself. We are all at risk. We know that AI continues to change the fraud and scam landscape. But we can all be vigilant and aware and that's what this webinar will help you to be.



My husband and I have been mailing mortgage checks for decades. This summer, we learned the hard way that we needed to stop doing that. Even as we took the envelope to the post office, someone still intercepted the check, washed it, wrote it out to themself for a larger amount, and mobile deposited it into a bank account. It took a couple of days of running around to rectify the situation. Luckily the credit union refunded the money, but the emotional toll was great.

We did what we were supposed to do. We used the non-washing ink on our check. We used a check printed by our credit union not a mail order check. We took the check to the post office. We followed the payment online to be sure it arrived on time - and still this happened. But it won't happen again, as we now take our payment directly to the bank. It is more effort on our part, and it seems a sad testament that we have to take such precautions, but we must face our reality and responsibility.

Knowledge is power, and we all need to know what the latest trends are, so we know how to protect ourselves from the scammers, fraudsters and hackers of the world. We hope that many of you will take advantage of the webinar on November 21, 2023.

# Charitable Giving – What's the best way for me to give?

Many people know they can deduct donations to charity from their income taxes...but increasing your knowledge of tax planning strategies can maximize your giving impact. Check out a couple easy tips!

**1.** Long-term appreciated assets—If you donate long-term appreciated assets like bonds, stocks or real estate to charity, you generally don't have to pay capital gains, and you can take an income tax deduction for the full fair-market value. This becomes much more efficient than giving cash!

**2.** Combine multi-year deductions into one year -Many taxpayers won't qualify for the necessary deductions to surpass the standard deduction threshold established by tax reform in 2017. However, you can still receive a tax benefit by "bunching" multiple years' worth of charitable giving in one year to surpass the itemization threshold. In off-years, you take the standard deduction.

**3.** Donor-advised fund - A donor-advised fund is a dedicated account for charitable giving. You can gift cash or appreciated assets (preferred) lump sum in one year, then recommend grants over time to any IRS-qualified public charity and invest the retained funds for tax-free growth. Donor-advised funds provide many benefits for organizing and planning giving, but they also offer advantages in terms of income, capital gains and estate taxes. This is similar to setting up your own Family Foundation that is a tax-free growth investment account after getting a full tax deduction on dollars


contributed, then giving to the individual charities over a long period of time.

4. Charitable Trust – Utilizing a Charitable Lead or Charitable Remainder Trust can be an incredibly efficient way to set aside dollars that will benefit both charity and also give you an income or return on your investment! This can be especially effective in years that there is a large capital event and we want to maximize tax savings.

There are many ways to structure your Estate and Charitable Giving Strategies that can be powerful tax reduction tools; if we are going to give anyway, we might as well do it in a way that will provide a potential tax deduction! 
