As I shared in my message this summer, MRSPA is working toward rebranding and planning for the future with the goal of growing our membership and moving MRSPA successfully into the mid-century. We know that most members join MRSPA for the pension protection advocacy. The MRSPA Legislative Committee meets regularly during the General Assembly session, reviews bills, takes positions, and provides testimony or input on bills that relate to our Legislative Priorities.

One of the goals in our Strategic Plan is to create a list of MRSPA members who have a personal relationship with a state legislator, county or city council member or executive, or local school board member. The committee would use this list when they need someone to reach out to a particular official on a particular topic or piece of legislation. Members with personal relationships might be asked to communicate with an official by email, by phone, or in person. Or they may be asked to be part of a panel of members who meet with or provide testimony on a piece of legislation. We are trying to locate two members who have a relationship with each elected or appointed official for our list.

We know that some of our members are elected or appointed officials. But we may

not know of others. We know that some of our members taught those officials or those officials' children or even grandchildren. We know that our members go to church or other religious institutions with officials. Our members are also in the same community groups or associations with officials. We just do not know which member and which official.

So, if you are reading this, and you are an elected or appointed official in the county/Baltimore City/state of Maryland, we would like you to let us know. If you taught or are in the same club as or the same church or religious institution as an official, and you would be willing to contact them about a legislative issue, we want to know. If you worked with any current official and are willing to possibly contact them for MRSPA at some future time, we want to know.

If you are willing to help MRSPA and our Legislative Committee to contact elected or appointed officials that you know personally, please send an email to <a href="mailto:mrspa@mrspa.org">mrspa@mrspa.org</a> and tell us your name, the name of the official(s) you know, what their title/position is, and their email address, if you have it. We would also like to know how you know the official (work, church, taught, etc.) or if you are the official.

Thank you in advance for helping us create our list of contacts for county/city/state officials!

# **Local Association Community Service Awards**

During the Annual Business Meeting each May, the MRSPA Community Service Committee recognizes local associations for work they do in their communities. A winner is selected from each of our three membership categories, small (1-199 members), medium (200-899 members), and large (900+ members). There were no nominations submitted by a small local association this year, so the committee selected two winners in the medium local category. Winning locals receive a certificate and \$150 to spend on continuing the work on their project. Awards were presented on May 6, 2025, by Kathy Campagnoli, MRSPA Community Service Committee Chair.



One-Room Schoolhouse project was selected as a winner in the medium local category. Charles County Retired School Personnel Association (CCRSPA) has worked for decades to pre-

serve the One-Room Schoolhouse in Port Tobacco. Members do everything from cleaning to roof repair. They serve as docents when the Schoolhouse is open to the public while also working to ensure the Schoolhouse is safe and clean for the second graders from CCPS who visit each year.



Washington County Retired Educational Personnel Association (WCEPA) was also selected as a winner in the medium local category for their *Adopt-A-Road* project. WCREPA members

gather on MD 63 between Huyetts Crossroads and I-70 four times annually to clear the road-side of unsightly and unsafe trash. Members enjoy working together and their time outdoors beautifying the roadway. The honks and thumbs up from appreciative passers-by are a big perk of the service activity!



Our large local association winner was *Shepherd's Cove Shelter* project by Prince George's Public School Retirees

Association (PGPSRA). Local association members provide hour long monthly informational sessions for the women and children at the center. The approved sessions for children include reading, math, science, and social skills. While adults focus on financial literacy, self-esteem building, yoga, goal setting, and mindfulness, among others. PGPSRA collaborates with other community organizations to provide the needed informational sessions.

The MRSPA Community Service Committee applauds all our local associations for all they do in the community and encourages more local associations to submit nominations in 2026. Congratulations to all the winners!




